- 1. Beginning in November 2021, the conversion of the Ticket System to All-Electronic Tolling (AET) on the Mainline plazas contributed to a significantly higher number of transactions at similar Toll rates in effect prior to the change. Previously, a trip on the Ticket System registered one transaction, now the same trip registers as a separate transaction for each Mainline plaza that a customer passes through.
- 2. Tolls were suspended on select West and Central Florida facilities from September 26, 2022, through October 15, 2022, due to Hurricane Ian. The toll suspension resulted in a revue loss of approximately \$24.3 million. The number of transactions in September 2022 and October 2022 includes un-tolled transactions that occurred during the suspension.
