While transactions are now being processed on a current basis, there are still outstanding uncollected electronic toll transactions. If and when these transactions are collected, such revenues will be recognized in the month in which they are received. The transaction amounts for Fiscal Year 2018-19 shown above reflect all transactions, but the revenue amounts only reflect actual collections. Certain months in Fiscal Year 2019-20 show year-over-year increases in revenue, partially as a result of TOLL-BY-PLATE transactions not being billed in the corresponding month in Fiscal Year 2018-19.
- 3. In September 2019, Tolls were suspended four to five days for Hurricane Dorian (depending on the Turnpike segment), resulting in an approximate loss of \$12 million of revenue.
- 4. Because of the public health crisis created by COVID-19, toll transactions and revenue declined year-over-year beginning with the second week of March 2020, presumably as a result of the rise in telecommuting, self-isolation, and reduced tourist traffic. On April 1, 2020, Florida Governor Ron DeSantis signed an Executive Order limiting movement to obtaining or providing essential services from April 3, 2020, to April 30, 2020.
